\*OFFICE ORDER\*

"With reference to Directorate of Education Himachal Pradesh Office letter NO.EDN-H(8)A(1)P.S.-/2006 dated 17-05-2006 and EDN-H(8)A(1)P.S.&/2006(MND) dated 20-06-2006. The inspection of Anglo Sanskrit Model

Sr. Sec. School Mandi District Mandi (H.P.) has been conducted by the inspection committee, constituted by the Principal Secretary (Edu) to the Govt. of Himachal Pradesh. The Department of Education, Himachal Pradesh has no objection to permit the Management/Pvt. SSS/HS/MS Anglo Sanskrit Model Sr. Sec. School Mandi District Mandi (H.P.) to seek affiliation from Himachal Pradesh Board of School Education, Dharamsala, District Kangra subject to the following conditions:-

1. That the grant of this permission shall however not entitle the school to any Grant-In-Aid from the Department/Govt. of H.P.
2. That No pupil shall be refused admission on account of his caste creed or religion and the pupil who has once been admitted shall not be treated differently from the other fellow pupils of his caste, creed or religion.
3. That all the A/c. matters as such Cash Book, fund register, Admission fees and tuition fees etc. shall have to maintain properly.
4. That the school shall have to furnish all information and returns as called for by the Department time to time.
5. That the school shall comply with the rules of the Department and direction as given by the Department so far as they are applicable to private schools in the interest of maintaining Education standard. The Dy. Director of Education shall have the authority to send any of his officer for inspection for maintenance of Education standard, holiday as per state Govt. etc.
6. That the school staff and students shall not take part in any agitation directed against the authority of Govt. or disseminate opinions tending to excite feelings of disloyalty or disaffection against the Govt.

7. The school shall charge the rate of tuition fee and subscription to boys funds in accordance with the scales prescribed or approved by the Education Department of H.P and school shall have to submit a school-wise list of tuition fee and funds to Dy. Director of Education.

8. That the School shall maintain the discipline properly.

9. That the school will abide by the norms as contained in H.P Notification NO.Shiksha-II(Ga)-1/98 dated 19-10-2004.

10. That the school will not claim any kind of grant/aid from the Department/ Govt.' of Himachal Pradesh.

The breach of any of the conditions specified above shall render the school defaulter and the Dy. Director of Education after conducting any enquiry through any of the officer so designated by him, shall have the power to cancel the N.O.C.

Recognition Certificate for the School under sub-rule (5) of rule 9 of Right of Children to Free and Compulsory Education Rules, 2011 for the purpose of sub-section- (2) of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir/Madam,

With reference to your application and subsequent correspondence with the school, we convey the grant for renewal recognition purely on provisional basis for class 1<sup>st</sup> to 8<sup>th</sup> class w.e.f 1<sup>st</sup> April, 2022 to 31<sup>st</sup> March, 2027 subject to the condition that the shortcomings which has been conveyed from time to time through this official website / letters should be removed in the meanwhile, failing which, no further extension in recognition shall be granted thereafter.

The above recognition is subject to fulfillment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII.

2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2011 (Annexure II)

3. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure

4. The School shall not deny admission to any child,

(i) for lack of age proof;

(ii) if such admission is sought subsequent to the extended period of ninety days for admission; and

(iii) on the ground of religion, caste or race, place of birth or any of them.

5. The School shall ensure that, -

(i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in that school;

(ii) No child shall be subjected to physical punishment or mental harassment;

(iii) All teachers are required with TET for JBT, TGT and C&V, deled, Bridge course passed as per RTE Act, 2009.

(iv) Every child completing elementary education is awarded a certificate as laid down under rule 19 of the Right of Children to Free and Compulsory Education, Himachal Pradesh Rules, 2011,

(v) Students with disabilities/special needs are given admission as per provisions of the Act,

(vi) The teachers are recruited with minimum qualifications as laid down under section 23(1) of the Act.

(vii) The teacher performs his/her duties specified under section 24(1) of the Act; and

(viii) The teachers shall not engage himself or herself for private teaching activities.

6. The School shall follow the syllabus on the basis of curriculum laid down by academic authority under sub-section (1) of section 29.


7. The School shall enroll students proportionate to the facilities available in the school specified in the section 19 of the Act.

8. The School shall maintain the standards and norms as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under:-

9. No unrecognized classes shall run within the premises of the school or outside in the name of school.
10. The school buildings or other structures or the grounds shall not be used during the day or night for commercial or residential purposes, except for the purpose of residence of any employee of the school, or for political or non-educational activity of any kind whatsoever.
11. The School shall be run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
12. The School shall not be run for profit to any individual, group or association of individuals or any other persons.
13. The accounts of the school shall be audited and certified by a Chartered Accountant and proper accounts statements shall be prepared as per rules. A copy each of the Statements of Accounts shall be sent to the Deputy Director/Block Elementary Education Officer every year.
14. The recognition Code Number allotted to your school is 5221. This may please be noted and quoted for any correspondence with this office.
15. The school shall furnish such reports and information as may be required by the Director of Education/Deputy Director/ Block Elementary Education Officer from time to time and comply with such instructions of the State Government/ local authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
16. Renewal of Registration of Society if any, be ensured.
17. The Government may specify additional conditions from time to time, for compliance.
18. "Capitation fee" means any kind of donation or contribution or payment other than the fee notified by the school.
19. "Child" means a male or female child of the age of six to fourteen years.
20. "Child belonging to disadvantaged group" means a child belonging to the Scheduled Caste, the Scheduled Tribe, or Other Backward Classes, who belongs to a family that is below the poverty line or is a disabled child as per the provisions contained in Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.
21. "Child belonging to weaker section" means a child belonging to such parent or guardian whose annual income is lower than the minimum limit specified by the appropriate Government, by notification.
22. Though the recognition to the Privately Managed School has been granted for five years, yet the concerned institution has to seek renewal on yearly basis before commencement of next academic session.
23. The school management should also ensure that the numbers of teacher recruited by them are not less than norms. If it is found on later stage that the institution is not fulfilling the PTR norms and has not recruited adequate teaching staff, recognition so granted shall be withdrawn without issuing any prior notice.
24. All untrained in-service teachers shall have to acquire minimum qualifications as laid down under section 23(1) of the Act up to the period 31<sup>st</sup> March, 2019 and no ineligible teacher shall be allowed to continue in-service thereafter.
25. The school management should also ensure the 25 % admissions of children belonging to weaker section and disadvantaged group as per notification dated 06.06.2015 of the Govt. under section 12 of RTE act.
26. The school management should also ensure the completion of all documents of vehicle engaged for the transportation of students. ( i.e ; Driver license, insurance of vehicle, passing validity, token tax, road tax etc.)
27. The school management should also ensure the implementation of guidelines on child safety in schools in view of judgment passed in CWP No 1516/2017 by the Hon'ble H.P. High Court. The said judgment / directions already convey to you by this office letter No 32015 - 32738 dated 25<sup>th</sup> 08.2017.
28. All schools shall strictly ensure the renewal of building safety certificate, fire safety certificate and rent deed of the institution time to time.
29. If, any institution is failed to comply the instructions mentioned above in that event the fresh recognition/renewal recognition of the institution shall stand automatically withdrawn/cancelled.
